**TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLE NO – AS 12 A 8165 (Mahindra Voyager), VEHICLE NO – AS 12 A 4456 (Mahindra Armada) and VEHICLE NO – AS 12 B 0012 (Ambassador)**

**CONDITION FOR SALE**

- 1 Subject to realization of reserve price where the same has been fixed by NERIWALM, Tezpur, vehicle shall be sold to the quotationer(s) bidding the highest price.
- 2 Every quotationer shall have to deposit Rs 2,000.00 (Rupees two thousand) only as earnest money for vehicle along with his quotation in the form of Call Deposit/Demand Draft in favour of Director, NERIWALM, Tezpur, which will be released to them on finalisation of the sale. Quotation received without earnest money will not be accepted.
- 3 The buyer(s) has/have to deposit the full amount of the sale value only in cash with the Cashier, NERIWALM, Tezpur within 2 (two) days of acceptance of his/their offered price. If the buyer(s) fail(s) to make payment of the sale value by the stipulated date, extension, if any, to be given in the matter of the date of payment shall be the discretion of the Director, NERIWALM, Tezpur subject to the payment by the buyer of compensation at the rate of 0.10% of the sale value per day for the default.
- 4 In the event of failure to make payment of sale value by the buyer within the stipulated period, the proposal for the sale of such vehicle shall be cancelled, the earnest money paid therefore shall be forfeited and the vehicles may be sold to other quotationers as the Director, NERIWALM, Tezpur may consider best without any notice to the defaulting quotationer.
- 5 The Director, NERIWALM reserve the right to reject any or all quotations without assigning any reason thereof.

**CONDITION OF VEHICLE**

- 1 The vehicle shall be sold on 'as is where is' basis. The vehicle will be sold on the assumption that the quotationers have inspected the vehicles and know that they are buying. However, any quotationer can inspect the vehicle on submission of his quotation accompanied by the earnest money.

**RISK**

- 1 The vehicle shall remain where they are in every respect at the risk of the buyer(s) from the date of acceptance of his / their offer by Director, NERIWALM, Tezpur and NERIWALM shall not be under liability for the safe custody or preservation thereof from the date onwards.

**DELIVERY**

- 1 The vehicles shall be taken from the site where they are parked with all faults and errors in description, if any, and no warrantee or guarantee shall be implied. The NERIWALM will issue sale release order signed by the Director to the buyer on production of cash receipt issued by the Cashier, NERIWALM, Tezpur for the full amount of the sale value decided upon by the NERIWALM on the basis of the valid quotation received.
- 2 The vehicle sold will be removed by the buyer(s) from the site where they are currently parked as early as possible (in any case within seven days). Delivery will be made only during working hours on all working days. The purchaser(s) will make own arrangements for transportation of the vehicle(s) and he will not be entitled to claim any facilities from NERIWALM.
